Power Requirements:

Fluid Management requires that each dispenser has its own dedicated power line. (Do not plug shakers into the same outlet) It is also recommended to use power strip surge protector to protect the computer from power surges.

- Older versions of color match software should be updated prior to install of new dispenser
- Spectrometer needs to be within 25 ft. of dispenser to avoid requirement of longer network cable
- If color matching system is not on site during the install, customer will contact color matching vendor to complete setup. (If this system is not onsite during install, FM does not return to install this)
- Full comprehensive training on color matching system to be provided by color matching vendor or paint rep. Fluid Management will only be able to provide limited training.

I have gathered all items on the "Staging Area Checklist" and our store is ready to schedule a technician. By signing, I realize that if the technician finds that any of the requirements have not been met, the installation could be rescheduled. Fluid Management reserves the right to bill for the technician's return time and travel when the requirements have not been met.
